Attached you will find the School Department's FY23 Capital Plan submission as approved by the School Committee on January 10, 2022. A few notes:

1. Mr. Graham and Mr. Lafleur have provided moment in time best judgment cost estimates. Please note that those items that may be subject to a partnership with the MSBA note town costs after state reimbursement.
2. Given the Town's support of a number of capital items over the past years, the new highest priority items on the facilities list section of the template are related to the Campbell Elementary School. We expect to hear from the MSBA in the coming months regarding whether we will be invited into the Core program for the Campbell. That process would be engaged in March 2022.
3. Please also note that items related to the Greenmont will be included in a Core application for that school, consistent with our recent conversations with MSBA representatives.
4. The technology item listed in the Capital Plan, while near the end of the document, is contained in the template's section related to technology, and is a high priority item for the district. I note this so as not to portray the item as lower on the district's priority list. The item relates to technology infrastructure equipment that is vital to ongoing academic operations.

I look forward to discussing our plan in further detail at an upcoming Town Capital Plan meeting.
