In accordance with Massachusetts General Laws (MGL), Chapter 87, Public Shade Tree Law, Section 3 (Cutting of Public Shade Trees; Hearing; Damages), the Town of Chelmsford Tree Warden will hold a public hearing regarding an application for National grid to remove public shade trees on July 15, 2024 at 1:00 pm at the Chelmsford DPW 9 Alpha Rd, Chelmsford MA. Any person interested or wishing to be heard on this matter should appear at the time and place designated.

The program included a tree-by-tree hazard assessment of public and private trees, along three-phase lines which serve the community. The work is recommended to remove hazard trees for additional clearance in order to reduce tree outage problems affecting large numbers of customers served by these main lines. National Grid's arborists have identified two (2) town trees for removal along town roads. Town trees located within the public way that are designated for removal have been marked with a small red ribbon and posted with a notice
