Hi Janet - Apologies for the back and forth on this piece. We have revised the design to be a designed riprap apron, designed in compliance with the US Dept of Transportation Hydraulic Design of Energy Dissipators for Culverts and Channels. We sized the apron based on the proposed discharge for the 100-yr storm event (100-yr Q = 6.40 cfs). In the hyperlink below I have provided the revised plan set (See detail & calcs on Sheet 2.22), and revised Narrative as the slope correction changed the peak flows slightly. Please let us know if you have any further questions / comments.
