

I, , Robert Donnelly, Alternate Clerk of the Board, hereby certify that the following is a detailed record of all its proceedings relative to this application submitted by: FKBE 1, LLC (the applicant), 1105 Lakeview Avenue, Dracut, MA; for a special permit and site plan review under Section 4.16.00 of the Zoning Bylaws for property located at 1934 Lakeview Avenue, a/k/a 81-91-101 Mill Street.

The applicant desires to transfer the existing special permit for the Beaver Brook Mill to FKBE 1, LLC and to divide the Mill property into two separate lots.

1. On July 13, 2005, an application of which is marked "A" is made part of this record and was presented to the Board.
2. A notice of public hearing, a true copy of which is marked "B" is made a part of this record, was published, posted and mailed to the "Parties in Interest" as indicated below;
 - a. Published in The Lowell Sun, a newspaper of general circulation in the Town on Wednesday, July 27, 2005 and again on Wednesday, August 3, 2005;
 - b. Posted in a conspicuous place in the Town Hall on Tuesday, July 19, 2005;
 - c. Mailed on July 22, 2005, postpaid to the applicant, abutters and owners of land within 300 feet of the property line as named in the certificate from the Assessors office, a true copy of which is marked "C" is made a part of this record, and to the Board of Selectmen, Building Inspector and the Planning Board of every abutting municipality.
3. On August 10, 2005, a hearing was held in the Lakeview Junior High School Community Room, at which opportunity was given to all those interested to be heard in favor, or opposition, to said application. The following evidence was presented at the hearing;
 - a. A letter dated July 21, 2005, from Attorney James A. Hall, Town Counsel.
4. Following the hearing the Board made the following findings regarding the land in question and the proposed use;
 - a. The presented proposal is in harmony with the purpose and intent of the Mill Overlay District By-law and Special Permit By-law.
 - b. The Board finds that the proposed project will not be detrimental or injurious to the neighborhood in which it is to take place based on the information presented.
 - c. The Mill Overlay District is appropriate for the site in question.
 - d. The submitted application package and presentation complies with the requirements of the Mill Overlay District By-law.

Dear Chairman Thibault:

I am in receipt of your letter dated July 18, 2005, relative to the above-captioned matter.

I can confirm to you that I did discuss this matter with Mr. Gorman's attorney, but I do not recall speaking with Mr. Gorman.

From what little background I know about the situation, it seems reasonable to me for Mr. Gorman to file for a new special permit, whereby he completes the work in two phases -- one phase as residential; the other phase as commercial. He could do this by having a new special permit issued and a new plan of land approved, whereby he could separately mortgage the commercial area from the residential portion of the development. Of course, the Board would have to require of Mr. Gorman assurances and/or a bond to guarantee that both projects would be completed in a timely fashion so that the Board would not be left with approving the residential portion of the project and be left with an empty commercial building or vice versa.
