As requested by the Board, attached please find renderings and schematic plans of the Project's two Proposed Playgrounds. The "Small Play Area" is proposed for the Playground located at the southern end of the Project Site near Building 10C. The "Large Play Area" is proposed for the centrally-located Playground adjacent to the parking lot behind Building 2B. Please note that both designs are each rated for an occupant load of slightly over 100, despite being labeled "small" and "large". These plans reflect schematic design only and the Applicant proposes a condition that final design of playground improvements and final equipment selection be approved post-permit by the Town Planner at a level equivalent to that shown in the schematic plans.




